#### **CURRENT LANGUAGE ARTICLE 2 SECTION 1**

Section 1. The Officers of this Lodge, their selection, duties, qualifications, and responsibilities shall be in accordance with applicable provisions of the IAM Constitution.

(a) All candidates for Lodge office and all delegates must have attended at least fifty (50%) percent of the regular meetings held during the 12-month period ending the date of the closing of nominations or appointments. The meeting register will be the sole determining proof of said attendance, which must be signed at the meetings by the members. Excusable absences from the attendance requirement rule shall be in accordance with Article B, Section 3 of the IAM Constitution.

(b) In the event any officer of this Lodge, elected or appointed shop steward, and elected or appointed committeeperson, absents himself from two (2) consecutive, regular meetings without being excused therefore, and if there is no controversy as to the refusal to excuse being proper, such officer shall be deemed to have resigned his office.

### **CURRENT LANGUAGE ARTICLE 2 SECTION 10**

Section 10. All elected/appointed Shop Stewards/Committee persons shall be compensated for attending the meetings at a rate equal to but not greater than the amount of their monthly dues. In addition, any Officer/Shop Steward/Committee persons attending the meeting or conducting union business using their personal vehicle for transportation shall receive mileage reimbursement as per the IRS mileage rate from the Austin, TX area based on your home address to 9502 Computer Dr., San Antonio, TX 78229. The mileage calculation should be provided using Google Maps. An excused absence by the President will be considered as attending the meeting. The only excused absence for compensation will be Union Business, Vacation, or bereavement. This change will take effect 2 months after approval by the members. Upon approval: The President will be required to send notification of this change by mail to all affected personnel concerned and post this information on all IAMAW bulletin boards.

### **PROPOSED CHANGE**

All elected/Appointed Shop Stewards/Committee persons who are employed at Austin Bergstrom International Airport, shall receive a monthly stipend in the sum of \$25 for attending the regular business meeting of this Lodge to help offset the cost of transportation to the meeting.
