- LAP Conference – To send 4 delegates to the 2025 Labor Assistance Professionals Conference in Las Vegas, NV July 13-17 2025. To pay 3 delegates 5 days lost time, per diem, 7 nights hotel at \$104.31 per night, transportation up to \$200 and registration fee of \$400. To pay 1 delegate 7 nights hotel at \$104.31 per night, transportation up to \$200 and registration fee of \$175
- District 141 Committee Conference – To send 6 delegates to the 2025 District 141 Local Committee Conference in St. Louis, Mo. October 27-29 2025, travel dates October 26<sup>th</sup>, and October 30<sup>th</sup>. To pay 4 delegates lost time, per diem, 4 nights hotel, hotel at \$209 plus tax per night, up to \$200 for transportation/parking and \$75 registration fee.
